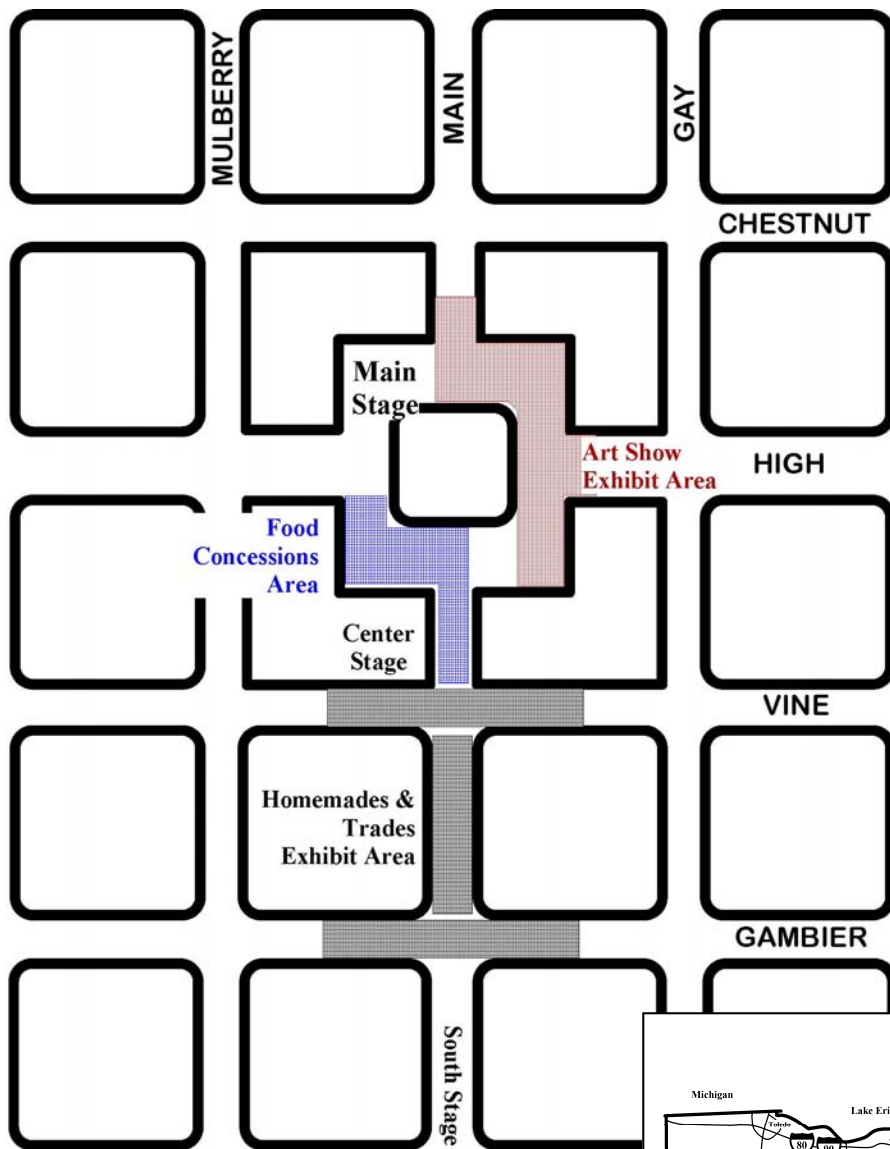
To Apply:

Deadline for Application:

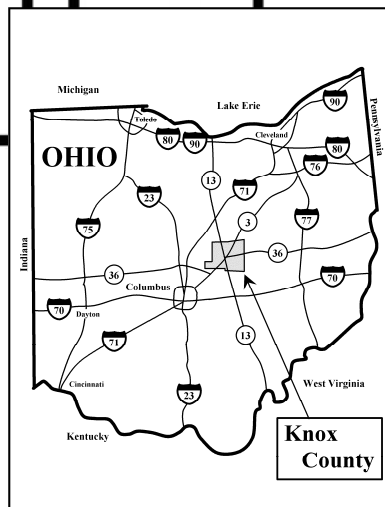
May 1, 2010 for first review; thereafter applications will be reviewed until the show is full.
